

## **Appendix 1 Chair Report**

As always, I'd like to thank all the members of the committee for your support and advice. Our 50 th Anniversary Year is certainly proving to be a busy one but its success so far has been down to great team work and careful planning. I'm very grateful to you all for the extra time you've given to ensure the events have been so successful.

## **ECR WEBPAGE**

The changes we agreed for our page on the Ramblers have been actioned.

Members can access the page using the following:

- Visit https://www.ramblers.org.uk
- Login using your user name and password
- Click on 'My Groups'
- If you have assigned ECR as your group in your Ramblers Account it should take you to East Cheshire Ramblers
- Click East Cheshire Ramblers and you'll find our information. The link to our Facebook page and our website both works.

#### **WALKS MANAGER**

Walks Manager has now gone live and can be accessed via the link on the Ramblers website. This is where all the available Ramblers walks are posted. I have successfully posted a walk! It's not complicated to post an individual walk; it is virtually the same process as the one we use for ECR. However, to upload a group of walks is slightly more complex as it involves creating a 'cvs' file, see page 18 of the Walks Manager Guidance. Teresa Marshall no longer wishes to take on the role of uploading walks.

It would seem we have three options:

- We could ask walk leaders to volunteer to post their walks on Walks Manager (we would still need a Walks Coordinator to approve the walk)
- Seek a volunteer who would be willing to become the Walks Coordinator and would be willing to posts all our walks each month.
- Or do nothing. Which I feel is a shame as we have had visitors in the past who have joined our walks.

I have written to Ramblers to see if a link could be created from Walks Manager to the ECR Notice Board, but I have not had a response. The Walks Manager Guidance has been circulated for your information.



## INTRODUCTION TO MANAGING SAFETY ON GROUP WALKS PROJECT

Over the coming months, a group of staff and volunteers at the Ramblers will be developing a new approach to managing safety on group walks, which they suggest will be more streamlined, consistent and proportionate than the current one.

Ramblers will be reviewing the support, tools and guidance for walk leaders so the association can ensure it is providing the skills and knowledge they need to confidently lead welcoming, safe and enjoyable group walks. Ramblers will be refreshing the walk leaders training and creating a handbook of best practice.

On Tuesday 4 July, a panel of speakers provided more information about the project in an introductory webinar. Unfortunately, I was away but the main details are outlined below:

Lucy Armitage, Trustee and Walk Leader, led on the importance of the project to ensure the Ramblers was meeting its legal and moral obligations to walkers and walk leaders. Another Trustee and Walk Leader, Mark Chung, set out what has happened so far. Mark described the work of the 'task and finish' group set up in 2022, and the commissioning of Martin Chester to research best practice in the sector, nationally and internationally, which led to three key findings:

- We have an excellent safety record, but things can go wrong, and we need to be able to evidence the high standard of our walk leadership.
- Walking with the Ramblers is different to walking with friends: both the charity and walk leader have a duty of care to our walkers.
- Not all walks are the same and we need to take a proportionate approach.
- Martin was unable to join the webinar but recorded a video delving deeper into his research which you can watch on Assemble.

Rebecca Birrane, Head of Walking Experience and Regional Engagement, outlined the timeline and next steps for the project, clarifying what this project means for walk leaders, leadership volunteers and partners.

A range of topics were discussed from recruitment to liability, training and catering for those who are less IT confident when creating new training and tools. There were lots of questions which we were not able to get through, and which we have now incorporated into an updated FAQ document which is now on Assemble.

If you wish to watch the webinar, the recording and slide deck are available through the Document Hub on Assemble.

One key outcome was the decision, from October 2023, not to require walk leaders to produce a WRITTEN RISK ASSESSMENT. Ramblers want to move to a Consistent Core Approach Risk Management rather than Risk Assessment.

Something which Dave Barraclough feels East Cheshire Ramblers have been doing very successfully for year! He has made a very detailed response to the detail shared in the webinar.



Until October 2023 the current guidance on Risk Assessment remains. Walk Leaders are required to complete a written Risk Assessment.

## SUPPORTING VULNERABLE WALKERS

I was contacted in May by a walk leader who raised questions about how we could support a strong but 'vulnerable' walker who wish to walk with us. I contacted Head Office and spoke to Claire Watkins who provided some very useful advice. She also shared a draft document which the Ramblers are putting together to help with sensitive conversations.

The following points are outlined in the guidance:

- A group walk needs to be safe, enjoyable, and inclusive for everyone.
- Walks are planned and led by volunteers.
- We need to understand the individual needs of a walker to plan for a good walking experience for all.
- Ramblers will do its best to support the full participation of everyone.
- However, there may be circumstances when walkers with disabilities may not be accommodated due to the type of the walk or a lack of appropriate and reasonable support available.
- Sometimes we have to say a walk is not suitable, but this does not necessarily mean every walk is unsuitable.
- The key is for both sides to consider what can be reasonably expected the walk leaders involved continued to offer sensitive support for the walker and the family and I would like to thank them all for their care, kindness and professionalism. If any of our walk leaders find themselves in a similar position, then please feel free to contact me.

The draft guidance has been circulated with my report.

Our walking programme is totally dependent on volunteer Walk Leaders. To support new Walk Leaders, or anyone thinking of becoming one we have organised another.

## **Appendix 3 Footpath Secretaries Report**

## **Prepared by Neil Collie**

**Annual Survey of Paths.** The annual survey of the 1295 rights-of-way in the ECR area is under way with a full complement of about 40 inspectors. One inspector had asked for some assistance due to injury. The deadline for completion of the survey is 29 September 2023. Currently (5 August 2023) 28% of the path inspections have been entered into the database.

Some unsolicited comments have been received from the head of the Public Rights of Way Unit that they find the database 'excellent for its up-to-date information and usefulness, and impressive in both volunteer input and software'.

**Footpaths Committee.** The Committee met on 27 April 2023 and on 4 July 2023 where progress on various initiatives were reviewed.

The project to improve the signage of the permissive path on North Rode FP 2 is progressing with Brian Richardson arranging a date for the posts to be installed.

Six rot-proof recycled plastic waymarker posts are to be purchased as a trial to determine the advantages and disadvantages of using recycled plastic (e.g., can they be sawn, will they accept nails and screws).

Roles and responsibilities on the Committee have been re-assessed as I have said I will not be standing as Footpaths Secretary in November 2023.

**CEC Public Rights of Way Unit.** Two new ROW Maintenance Officers have been recruited by CEC and funds have been secured for an additional post in the year 2023/24. In addition, two new officers have been recruited to the Legal Orders team to fill vacancies. There has also been an increase in the annual maintenance budget for 2023/24.

An application by North Cheshire Riders to upgrade Great Warford FPs 23 and 25 to bridleways was rejected by the CEC Public Rights of Way Sub-Committee in July 2023 due to insufficient evidence.

**Lost Ways.** The Parish Co-ordinators have now visited all the sites of the 'worth-considering' paths which had been identified by Colin Park from earlier work by the consultants Land Aspects working for the Countryside Agency. These have been considered by the footpaths committee and 7 paths identified as worth researching in depth by any 'Lost Ways' volunteers co-ordinated by Keith Anderson. Note that in addition to these paths a large number of other possible Lost Ways have been identified by RA Central Office which have not yet been assessed as to whether they add significantly to the path network.


## **Appendix 4 Membership Report**



## **Appendix 8** Walkers with Disabilities Conversation

Published by Rambers Head Office and issued to our Chair

Walkers with disabilities conversation framework for Area Chairs, Group Chairs, Supporter Care Team (SCT), Walk Experience Team and Regional Engagement Team (RET).

#### Introduction

At Ramblers we want to involve and welcome as many people as possible to join our wonderful walking community and to enjoy the wider benefits that walking can bring.

We understand that from time-to-time there may be someone with a disability (both visible and invisible) who either wants to join or has joined a Ramblers walk.

This short guide will support you in the conversations you may have with disabled walkers.

## What might need to be considered during conversations with disabled walkers?

- A group walk needs to be safe, enjoyable, and inclusive for everyone.
- Walks are planned and led by volunteers.
- We need to understand the individual needs of a walker to plan for a good walking experience for all.
- Ramblers will do its best to support full participation of everyone. However, there may be circumstances
  when walkers with disabilities may not be accommodated due to the type of the walk or a lack of
  appropriate and reasonable support available. Sometimes we have to say a walk is not suitable, but this
  does not necessarily mean every walk is unsuitable.
- The key is for both sides to consider what can be reasonably expected.

### How should we approach the conversation to find a reasonable solution?

- Assuming the person making the enquiry has told you that they have a disability explain that you will need to understand what works for them so you will need to ask them some questions. Ask if you have their consent to do this.
- We understand that conversations of this kind can be sensitive and so please do explain that the
  questions are for a reason and to help you and the person enquiring to consider the suitability of the
  walk for them.
- Reassure the person that any information they give you will only be shared with those who need to know to ensure their safety.
- Explain that you are not an expert be honest about your level of knowledge in these matters. You need them to help you.
- Don't make any assumptions **everyone is different**. Explain that you want to work out a mutually agreed solution and this may also involve the Walk Leader or Walk Coordinator.
- Note what words they use about their disability. If you are unsure how to say something, ask them to help or clarify for you.
- It's also OK to ask if you can call the person making the enquiry back if you need to run anything past a colleague or another volunteer so you can be supported as well.

#### Having a helpful conversation



- Be positive but also realistic. "Are there any questions they would like to ask about Ramblers walks?"
   Explain that every walk is different, and they may encounter the following: steep paths, steps, stiles, tree stump hazards, adverse weather conditions, length/time it takes, uneven or difficult paths, stiles or gates.
- Use open questions such as "tell me what aspects of the walk you might find difficult". Prompts might
  include: coping with steps, walking up steep hills, uneven or slippery ground, how fast the group walk,
  hearing instructions or joining in conversations, understanding the briefing (too much information at
  once), climbing over stiles, needing to stop at certain times.
- Again the Walk Leader and Walks Coordinator should be able to help with more detail on each individual walk advertised.

Discuss the next steps and confirm the best way of communicating with the person making the enquiry.

### Further support and help available - It's sometimes OK to say no!

Bear in mind a Group will have a bank of Walk Leaders and a varied walk programme so the walker will need to contact each Walk Leader to establish the suitability of each walk.

Disabled walkers when it's appropriate and safe, can bring someone along to support them on the walk.

It's also important to explain that the walking groups may not be able to provide the level of support that the disabled walker may require. Walking groups should feel confident to explain that its reasonable for them not to offer additional support if they choose not to. However, if walks can accommodate a person with disabilities then this is also great!

There might also be the option of referring the person to local Wellbeing Walks where walks might be more suitable. Again, this needs to be assessed on a case-by-case basis.

If additional support is required, the disabled person should be able to identify this from other sources e.g. a social worker or carer.
